### INDUSTRY OVERVIEW

The furniture industry is an integral part of daily life in South Africa and an important economic sector. It is a labour-intensive industry, providing job opportunities throughout the length and breadth of the country. Furniture manufacture draws on local materials and local skills, and provides an outlet for South African design. South African families invest hard-earned money in buying furniture which we often pass on to our children. This industry should be nurtured and expanded.

The industry has a long history in South Africa and a significant skills base. There are also large and significant South African companies in raw material production, manufacturing and retail, a number of whom have a presence throughout Southern Africa. On the manufacturing side of the industry, the vast majority of companies in the sector are small companies (61% of all entities listed with the furniture bargaining councils employ fewer than 10 people) and many family-owned firms.

Despite its long and rich history, the industry experienced significant decline over the past decade. The sector was affected by a number of factors, which caused disruption in the industry and undermined some of its historic strengths. Demand stagnated, imports rose and a number of important manufacturing companies collapsed as did some retail entities. Our capacity to manufacture furniture declined and the sector became more fragmented and more oriented to imports. Several large manufacturing companies closed down especially in the 'case goods' subsector. This is clearly visible in the statistics on manufacturing output. The output from South African furniture manufacturers peaked in the period before the Global Financial Crisis, following which there was collapse in output as the economy faltered. While output had begun to recover in the subsequent period, it has been in decline since 2015.

Over the past two years, conditions in the industry have begun to shift, creating an important opportunity for the regeneration and expansion of the sector.





### CHAIRMAN'S REPORT

The past year provided the furniture industry with many challenges beyond its control.

The COVID-19 pandemic is still with us, with enforced lockdowns having an immense effect on imports and exports and the availability of raw materials. To exacerbate the situation, the country had to contend with the civil unrest and accompanying looting during July, with devastating effects to the furniture manufacturing and retail industries.

These challenges do have a way to motivate and prompt the industry into action, which led to many initiatives that were activated and completed during the year. The Furniture Industry Master Plan (FIMP) was adopted, which played a major part in reorganising SAFI into seven chambers to streamline its support and services to the furniture sector. These chambers include the lounge, bed and mattress, case goods, office, chair and school, kitchen, raw materials and retail chambers with the SAFI administration and management team driving the data management and strategic relationships work stream.

By building a globally competitive and transformed furniture industry, we will be able to shape lives in every home, school and workplace in Africa and beyond. We have therefore prioritised our activities into four key pillars, namely market access, defending our industry with trade interventions and remedies, providing a platform for market intelligence by building a data platform to support the furniture value chain and improving the technical skills of our workforce.

We have set various goals with specific outcomes in our rebuilding phase where we plan to increase the market share of locally manufactured furniture within furniture retail by 50% by 2025, develop an evidence-based export and export marketing strategy by end of 2022, as well as complete a manufacturing and productivity benchmark study. This study will enable local manufacturers to implement smart technologies and modern manufacturing practices to become globally competitive by 2026.

During the past year we presented the 3rd Annual Furniture Sector Forum successfully, engaged with local government during on-site visits in the Western Cape, as well as supported the eThekwini Furniture cluster in KZN. I have also been privileged to be part of a panel discussion at the Dubai Expo.



The Board wants to celebrate and congratulate SAFI on its 5-year anniversary. For the past five years SAFI has served the furniture sector as a reliable and pivotal role player, while proving itself as a credible connector between government, industry and labour.

On behalf of my fellow board members, we wish to welcome the new members of the board and thank them in advance for strengthening the board in general and the chambers in particular. To our executive and operational team, thank you for your continued diligence, drive, commitment an uncompromising approach of putting SAFI first. I look forward to seeing how we are going to "BE THE CHANGE WE SEEK" by taking the words of former US president Barrack Obama to heart. "We remember, we rebuild, we come back stronger." May this be at the centre of our future growth and transformation into a globally competitive industry.



### SARS FURNITURE FORUM

In June 2019 the South African Furniture Initiative (SAFI) partnered with Industry members and the South African Revenue Services (SARS) to form the first SARS Furniture Forum that will address the Industry's challenges and provide support to inform trade and industrial policy directed at decreasing imports of furniture into South Africa and develop and implement a plan aimed at preventing illegal import practices to curb the spread of illegal and poor quality imports which flood the local furniture market. Initial discussions revealed that in order for SARS to put systems and mechanisms in place to monitor and curb illegal and poor-quality imports, they require information from Industry to identify the behavioral patterns for illegal activity like, under declaration, deliberate misclassification, under invoicing, etc. Further exploration revealed that this information is not readily available for the furniture industry due to factors like vague tariff headings and poor enforcement because of lack of product knowledge by Customs Officials. To this end, the Forum finalised a 5-phase approach to provide SARS with the information and support they require for monitoring and enforcement of illegal and poor-quality imports of furniture into South Africa.



Industry to work with relevant stakeholders on labelling/identification of origin of furniture products (imported, made in South Africa, Raw Material content, etc.) – PSA, SAFI, Retailers, DTIC).

In terms of progress made to date on our 5phase approach, the industry has reviewed the first batch of tariff codes for clearer classification and this was submitted in August 2020 and gazette for implementation from 01 January 2021.

The Industry is also creating learning material for SARS Customs officials for seating products to enable them to do better monitoring and enforcement of these products in relation to under declaration or miss-classification. The training is expected to commence in April 2022. There is also work underway on a proposal to update quality standards specifications on certain office furniture products that will be submitted to SABS for consideration.

As we progress through the ongoing 5-phase approach activities, SAFI is confident we will reach success as long as stakeholders commit and collaborate to finding local long term sustainable solutions for the industry.

Following the success of our past two Furniture Sector Forums, this year we acknowledge the challenges faced, build on what we have, and take on the challenge of an optimistic future by "being" the change.

#### Theme: We remember, we rebuild, we come back stronger.

#### With this positive viewpoint, we are working towards the following from 2022 and beyond:



- Develop a skills strategy to drive skills programmes to build technical capabilities and design skills to create uniquely SA products by April 2022.
- Report on the transformation initiatives within the furniture industry to develop an industry specific transformation strategy by 2022.
- Develop evidence-based export and export marketing strategy by end 2022.
- Roll out Non Tariff Barrier strategy to prevent illegal imports and implement appropriate certification process in respect of all furniture imports by 2023.
- Increase the market share of locally manufactured furniture within furniture retail by 50% by 2025.
- Complete manufacturing and productivity benchmark study to enable local manufacturers to implement smart technologies and modern manufacturing practices to become globally competitive by mid 2026.
- Achievement of 50% target SACU and SADC import replacement.





### AUDIT COMMITTEE REPORT

This report is in compliance with the requirements of the Companies Act of South Africa, No. 71 of 2008 (the Act), and the King IV Report on Corporate Governance for South Africa 2016 (King IV) on 1 November 2016. King IV is effective in respect of financial years commencing on or after 1 April 2017. King IV replaces King III in its entirety.

#### **AUDIT COMMITTEE PURPOSE**

The purpose of the Audit and Risk Committee is to assist SAFI to fulfil its role and obligations in terms of its corporate governance duties in relation to risk management, internal control and financial reporting. In addition, the Audit and Risk Committee is responsible for overseeing the professional and other business risks affecting SAFI.

This includes the assessment of the effectiveness of the various risks, independence and compliance of policies within SAFI.


